TAPsd provides Corporate Structuring services for SMEs and new entrepreneurs. Since 'prevention is better than cure', we, here in TAPsd,

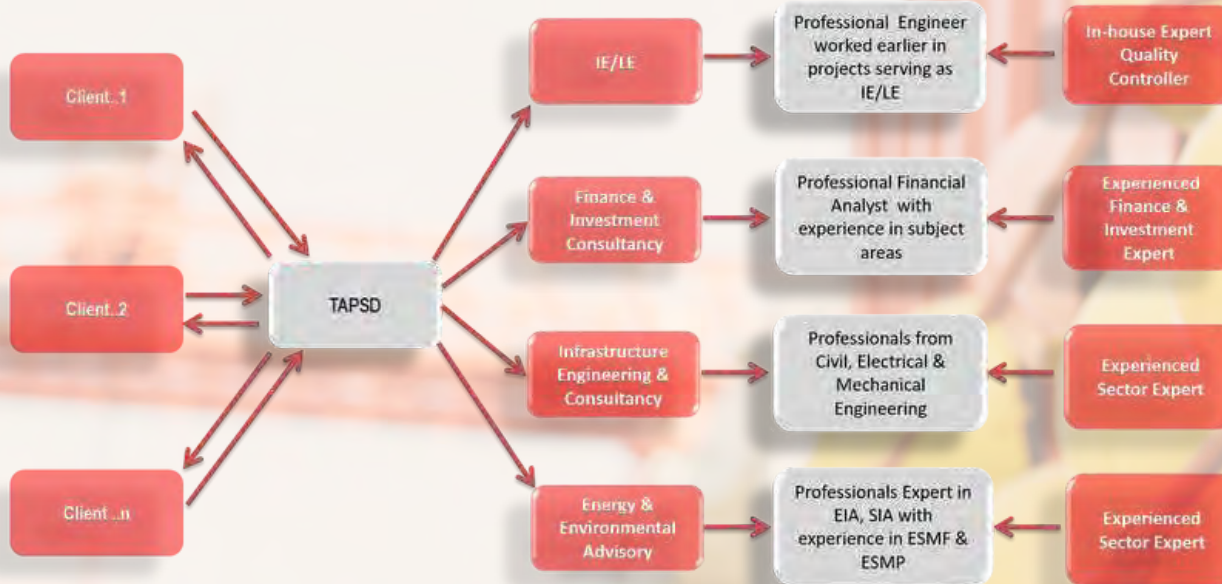
focus on adopting corporate cultural tools and techniques from the early stage of doing business. Culture is a long process of transforming and preparing an organization for the next level.
